

# NOTICE OF ELECTION

## UK Parliamentary Election For the North East Hampshire Constituency

1. An Election is to be held for of a Member of Parliament to serve North East Hampshire.
2. Nomination papers can be obtained from the offices of the (Acting) Returning Officer, Civic Offices, Harlington Way, Fleet, Hampshire, GU51 4AE, during the times stated below.
3. Nominations papers must be delivered to the (Acting) Returning Officer Civic Offices, Harlington Way, Fleet, Hampshire, GU51 4AE on any day after the date of this notice, on Monday to Friday 10 a.m. to 4 p.m. (excluding bank holidays) but no later than 4pm Friday, 7th June 2024.
4. The £500 deposit can be paid by legal tender or by means of a banker's draft from a drawer which carries on business as banker in the United Kingdom or, with the (Acting) Returning Officer's consent, in any other manner (including electronic transfer of funds).
5. If the election is contested the poll will take place on Thursday, 4th July 2024.
6. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Tuesday, 18th June 2024. Applications can be made on line [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote) .
7. New applications to vote by post, and amendments or cancellations of existing postal votes or proxy vote arrangements must reach the Electoral Registration Officer at Civic Offices, Harlington Way, Fleet, Hampshire, GU51 4AE by 5 p.m. on Wednesday, 19th June 2024. For electors resident in Basingstoke and Deane Borough the address is Civic Offices, London Road, Basingstoke, RG21 4AH.
8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on Wednesday, 26th June 2024.
