After the close of the consultation period, all representations will be forwarded to the Independent Examiner who will assess whether the Neighbourhood Plan meets the basic conditions as required by legislation.

After this, if all necessary processes and conditions have been met including passing a local referendum if required, Hart District Council will 'make' the Neighbourhood Plan so that it becomes part of the development plan for Hart District and used to determine planning applications in the locality.
