1 Introduction

- 1.1 This Infrastructure Funding Statement (IFS) presents information on developer contributions secured through planning obligations for the reporting period 1 April 2021 to 31 March 2022.
- 1.2 A planning obligation is a legal agreement entered into under section 106 of the Town and Country Planning Act 1990 to mitigate the impacts of a development proposal. A number of policies in the <u>Hart Local Plan 2032</u> are used to secure infrastructure improvements through planning obligations.
- 1.3 Strict rules apply to planning obligations to ensure that permissions cannot be bought or sold. They must be:
 - a) necessary to make the development the development acceptable in planning terms,
 - b) directly related to the development, and
 - c) fairly and reasonably related in scale and kind to the development.
- 1.4 Further information regarding planning obligations is set out in national Planning Practice Guidance.
- 1.5 Developer contributions can be financial payments towards off-site infrastructure improvements, or they can be provided directly by the developer, usually on-site, for example affordable homes, open space or a new school. Appendix 1 provides some illustrated examples of infrastructure and affordable homes delivered during 2021/22.
- 1.6 Some financial contributions are spent by Hart District Council, including 'district leisure' and affordable housing. Others are transferred to other organisations, primarily:
 - Hampshire County Council (HCC) mainly for education, transport and SAMM (see below). HCC must produce an IFS of its own each year.
 - Town and Parish Councils, notably for open space and leisure contributions ("parish leisure"). Parishes request the money from HDC to spend on appropriate local projects.
- 1.7 In Hart, planning obligations are sometimes used to secure SANG (Suitable Alternative Natural Greenspace) and SAMM (Strategic Access Management and Monitoring). These are avoidance and mitigation measures needed to protect the Thames Basin Heaths Special Protection Area from the impacts of additional recreation on the SPA (see Policy NBE3 Thames Basin Heaths

- the Council's <u>Planning Guidance</u> page). Contributions to SANG and SAMM secured through planning obligations are reported in this document.
- 1.8 All figures expressed in the document are net of any monitoring fees or charges. Typically, the Council receives 5% of the value of the contribution in fees for the work undertaken to ensure that the planning applications are implemented in accordance with the signed agreements and any planning conditions.
- 1.9 Most contributions are indexed linked to ensure that they reflect current values when collected with the relevant index being outlined in the agreement. In most cases the indexes used are set by the Building Cost Information Service.
- 1.10 Section 106 Agreements are also subject to interest for late payments this is typically applied at four per cent above the Bank of England base lending rate.
- 1.11 This IFS reports on planning obligations. It does not refer to any Community Infrastructure Levy receipts as Council is not a CIL charging authority. The Council did consult on a Preliminary Draft CIL Charging Schedule in winter 2021 and is considering next steps in light of proposals to introduce a new form of Infrastructure Levy through the Levelling Up and Regeneration Bill.

2 S106 contributions summary

- 2.1 During 2021/22 the Council entered into six S106 agreements securing:
 - £553,276 of financial contributions comprising:
 - £525,302 affordable housing contributions
 - £27,974 SAMM contributions
 - 6 affordable homes
 - 0.726 of SANG land

- 2.2 During 2021/22 the Council received £4,774,218 comprising:
 - £1,279,014 for SANG
 - £1,025,549 for District Leisure
 - £675,825 for Education
 - £505,006 for SAMM
 - £502,717 for Fleet Pond.
 - £434,446 for Parish Leisure
 - £271,374 for Highways
 - £53,325 for Affordable Homes

- 2.3 During the monitoring period, a total of £540,163 was received in SAMM contributions from a combination of S106 planning obligations and Grampian Conditions.
- 2.4 For the items listed below, the Council held the following amounts of s106 monies prior to 2021/22 i.e. at April 2021: ():
 - £629,090 for Parish Leisure (the Council holds this money pending any requests from the identified Parish Council to spend on local projects).
 - £2,409,644 for District Leisure
 - £179,674 for a NEAP (Neighbourhood Equipped Area for Play)
 - £5,021 for SAMM
 - £559,269 for Fleet Pond
 - £20,905 for Highways
 - £77,939 for town centre improvements
 - £19,719 for allotments

- 2.5 Section 106 monies spent (including transferring it to another person to spend) during 2021/22 are shown below. These amount to £137,952 spent by the Council and £1,445,366 transferred to other organisations:
 - £5,565 District leisure Hazeley Heath grazing project
 - £74,534 Fleet Pond Fleet Pond Corridor path widening works
 - £57,853 Allotments Edenbrook Country Park allotments
 - £26,471 Parish leisure Transferred to Blackwater Town Council for sports pitch and community facility maintenance equipment
 - £738 Parish leisure Transferred to South Warnborough Parish Council for plants and landscaping
 - £3,255 Parish leisure Transferred to Winchfield Parish Council for defibrillators
 - £2,435 Parish leisure Transferred to Yateley Town Council for Chandlers Pond works
 - £365,870 SAMM Transferred to HCC
 - £122,352 Transport Transferred to HCC
 - £924,245 Education Transferred to HCC

2.6 Some illustrated examples of how contributions have been spent are set out at Appendix 1.

- 2.7 Non-monetary contributions secured through planning obligations and delivered during 2021/22 were 201 affordable homes (see Appendix 2 Table 5 for details of the sites, and Appendix 1 for some illustrated examples).
- 2.8 It is anticipated that the following s106 payments from developers will be triggered during 2022/23:
 - £500,000 off-site affordable homes contribution: Fleet Police Station, 13 Crookham Road, Fleet (19/02659/FUL)
 - £86,381 leisure and open space contribution: Watery Lane, Church Crookham (Crookham Village Parish) 14/00504/MAJOR
 - £722,272 Hart Leisure Centre contribution Land north of Netherhouse Copse, Fleet (16/01651/OUT)
 - £406,105 off-site affordable homes contribution Wingate Lane, Long Sutton15/00424/FUL.

Appendix 1: Examples of infrastructure delivered

Fleet Pond Corridor

2.9 Over the monitoring period, funding received through S106 Planning Obligations contributed towards the delivery of the Fleet Pond Corridor. The scheme, which was completed in July 2022, provides greater connectivity for walking and cycling between Hartland Village and Fleet Station via Fleet Pond. The project aims to encourage a shift towards active modes of travel that will improve the health and wellbeing of residents while aiding the Council in meeting its climate change objectives.

Hart's Green Garden

S106 contributions have also supported the delivery of Hart's Green Garden. The sustainable and inclusive gardening space at Edenbrook Country Park, Fleet aims to bring together people from a diverse range of backgrounds through a shared interest in gardening. The scheme will provide 94 individual plots for residents, with a range of shared facilities and spaces to encourage connection between users. The site will also be home to the 'Minding the Garden' area, where Hart Voluntary Action will be running social and therapeutic horticultural activities.

Parish S106 spend

Funding from S106 Planning Obligations has also supported our Parish Councils in delivering new and improved infrastructure within local communities. Blackwater and Hawley Town Council utilised funding from development in their area to purchase a new tractor with lawn mower attachments for the maintenance of sports pitches and community facilities. Funding in Winchfield was used by the Parish Council to purchase life-saving defibrillators which are located at the Barley Mow pub and the Village Hall. South Warnborough Parish Council used S106 contributions for planting and landscaping, while Yateley Town Council completed works at Chandlers Pond.

Hartland Village, Fleet

During the monitoring period, the first 20 affordable homes were delivered at Hartland Village, Fleet. The homes delivered are a mixture of 1-, 2- and 3-bedroom apartments and homes and are comprised of 9 affordable rented homes and 11 shared ownership homes. The development will deliver a total of 300 affordable homes over the 11 phases. This is comprised of 193 affordable rented units and 107 shared ownership units.

Dukes Meadow, Riseley

The final 23 affordable homes were completed in the north west of the district at Land at Odiham Road, Riseley (16/02989/OUT). The completed affordable units are comprised of 20 affordable rented homes and 3 shared ownership homes. The homes were delivered as a range of 1- and 2-bed flats, and 1-, 2-, and 3-bed houses.

Broden Stables, Crondall

During the monitoring period, the first 4 affordable homes were delivered at Broden Stable, Crondall (16/02377/FUL). These comprised of 2 affordable rented homes and 2 shared ownership homes. The development will provide a total of 12 affordable homes made up of 8 affordable rented units and 4 shared ownership units.
