I am writing to support the new evidence in the Draft Crookham Village Neighbourhood Plan with regard to the gaps between Crookham Village, Church Crookham, Fleet and Dogmersfield (Policy NE01). Specifically, I support the statements that the gaps are essential to prevent coalescence and to maintain the character of the Village and its setting. The gap is important is creating a sense of community and to prevent the Village become part of a large conurbation that swallows up its identify.

A precedent has been set by the developer who withdrew his Appeal (as part of the Inquiry on the 22nd March, 2019) in part because the Hook Neighbourhood Plan contained a definition of the strategic Gap between Hook and Newnham. This stresses the importance of the definition of the Gap between Crookham Village and its surrounding areas and making sure that that definition stands up to Appeal.

The Gaps between the villages and towns within Hart are in dire danger of disappearing and the joining up of all our local communities into a single urbanisation will be the result. The NPPF and the decision by

the Ministry of Housing, Communities and Local Government to diminish the importance of Gaps in planning policy has resulted in the pressing need to protect our local settlements.
