The examiner will retain the data until we have made the relevant statutory decisions on whether to adopt the plan and the deadline for a Judicial Review has passed, which is six weeks after the decision notice has been published.

We write in support of the whole Policy, with its coherent and balanced arguments based on evidence that the Gap provides the essential setting of Crookham Village as a distinct settlement with its own sense of place.

We commend the landscape evidence on preventing the physical and visual coalescence of the adjacent two settlements of Dogmersfield and Church Crookham with Crookham Village. We support the need also for the Gap as defined in the Policy to preserve the linear nature of Crookham Village and its Conservation Area.

We endorse the further evidence on the necessity of preserving the views of the historic and listed buildings that enrich the scenic qualities of the village and the wider area and provide its landmarks. We note and support the further evidence given that wildlife rely on the Gap for their habitats. We observe also that the Gap provides corridors though which wildlife can migrate around the area, which is particularly important when the adjacent significant Gap to the north has been reduced to a single line of trees by the Netherhouse Copse development.

Additionally, we observe that within the Gap there is a number of footpaths that provide open access to the surrounding countryside. These paths are used not only by the residents of Crookham Village, but also form routes by which walkers along the Conservation Area of the Basingstoke Canal can divert through Crookham Village and thus back into Fleet. Preserving the character of these footpaths along their full

length is essential to the maintenance of the Gap.

We believe that the Policy meets the evidence-based requirements of the Planning System to fully justify the maintenance of the Gap as essential to the character of Crookham Village.
